HIGH SCHOOL GRADUATION REQUIREMENTS

The Board of Trustees desires to prepare each student to obtain a high school diploma to enable them to take advantage of opportunities for postsecondary education and employment.

Course Requirements

To obtain a high school diploma, students shall complete at least the following courses in grades 9 through 12, with each course being one year unless otherwise specified:

1. Four courses in English (Education Code 51225.3)

2. Two courses in mathematics (Education Code 51225.3)

At least one mathematics course, or a combination of two mathematics courses, shall meet or exceed state academic content standards for Algebra I. (Education Code 51224.5)

Completion, prior to grade 9, of algebra coursework that meets or exceeds state academic content standards shall satisfy the algebra coursework requirements but shall not exempt a student from the requirement to complete two mathematics courses in grades 9-12. (Education Code 51224.5)

3. Two courses in science, including biological and physical sciences (Education Code 51225.3)

4. Three courses in social studies, including United States history and geography; world history or European History AP, culture and geography; a one-semester course in American government and civics; and a one-semester course in economics

5. One course in visual or performing arts, foreign language, including American Sign Language, or career technical education (Education Code 51225.3)

To be counted towards meeting graduation requirements, a course in career technical education shall be aligned to the career technical model curriculum standards and framework adopted by the State Board of Education.

6. Two courses in physical education, unless the student has been otherwise exempted pursuant to other sections of the Education Code (Education Code 51225.3)

7. One-semester course in Health

8. Ten credits in an approved Career/Technical Education course or courses

9. Five credits in an approved Computer/Technology course

Beginning with the class of 2018,

1. The successful completion of AVID 1 and AVID 2 (4 total semesters with a grade of a D or higher each semester) fulfills the CIT graduation requirement.

2. Any two semesters of AVID with a D or higher each semester, fulfills the 10 credits of Career Technical Education required for graduation.

3. Based upon the alignment between the AVID curriculum and both CIT and Career Technical Education, the successful completion of AVID, as outlined in numbers 1 and 2, fulfills the CIT and Career Technical Education graduation requirements.

Because the prescribed course of study may not accommodate the needs of some students, the Board shall provide alternative means for the completion of prescribed courses in accordance with law.

Valedictorian

The selection process for each school's valedictorian is as follows:

1. All students who have a GPA of 4.2 or higher and have earned a Blue Trustee Seal Diploma will be recognized as Valedictorian(s) of the graduating class.

2. If there are no students at the first criterion level, then those students that have earned a GPA of 4.1 and have achieved a Blue Trustees Seal Diploma will be recognized as Valedictorian(s) of the graduating class.

3. If there are not students at the Criterion 1 or 2 level, then the student(s) with the highest grade point average who has earned a Blue Trustee Seal Diploma will be recognized as the Valedictorian(s) of the graduating class.

High School Exit Examination

As a condition of high school graduation, each student completing grade 12 shall have successfully passed the state exit examination in English/language arts and mathematics unless he/she receives a waiver or exemption.

Supplemental instruction shall be offered to any student in grade 9-12 who does not demonstrate "sufficient progress," as defined in BP 6179 - Supplemental Instruction, toward passing the exit exam. (Education Code 37252, 60851)

Students who have not passed one or both parts of the exit exam by the end of grade 12 shall have the opportunity to receive intensive instruction and services for up to two consecutive years after completion of grade 12 or until after they have passed both parts of the exam, whichever comes first. (Education Code 37254)

In addition to intensive remedial instruction, the district shall offer students who have passed all state and local graduation requirements except one or both parts of the exit exam the following options for two years beyond their regular senior year or until they pass the exam, whichever occurs first.

The Superintendent or designee shall regularly report to the Board regarding the number of students who have fulfilled all local and state graduation requirements except for the passage of the exit exam and the resources that have been offered to such students.

Certificates of Credit Completion/Achievement

Students who passed all of the district's course requirements by the end of their senior year but are unable to pass the high school exit examination shall receive a Certificate of Credit Completion.

Special education students who are in the Mildly Developmentally Delayed (MDD) program and have met all criteria as set forth in their Individualized Education Program (IEP) will be awarded a Certificate of Achievement if they have not passed the California High School Exit Exam (CAHSEE). These students who are awarded the Certificate of Achievement will have all privileges of participating in commencement ceremonies and all other related commencement activities.

The Superintendent or designee shall regularly report to the Board regarding the number of students receiving a Certificate of Credit Completion and the resources that have been offered to such students.

Retroactive Diplomas

The district may retroactively grant a high school diploma to a former student who was interned by order of the federal government during World War II or who is an honorably discharged veteran of World War II, the Korean War, or the Vietnam War, provided that he/she was enrolled in a district school immediately preceding the internment or military service and he/she did not receive a diploma because his/her education was interrupted due to the internment or military service. (Education Code 51430)

The district may retroactively grant a diploma to a deceased former student who satisfies the above conditions. The diploma shall be received by the deceased student's next of kin. (Education Code 51430)

In addition, the district may grant a diploma to a veteran who entered the military service of the United States while he/she was a district student in grade 12 and who had completed the first half of the work required for grade 12. (Education Code 51440)
