CONGRATULATIONS are in order! Graduation for the **Class of 2025** is scheduled for **Thursday**, **June 5**, **2025 at 7:00pm**. This will be a ceremony to honor you, the student, for your completion of the graduation requirements set by the State of California and the El Monte Union High School District Board of Trustees. During the ceremony, all students will wear cap and gowns, have their name announced to the audience, and receive their diploma cover. Attention will be focused on individuals as well as class achievements.

To ensure that the ceremony is meaningful and dignified, which the graduating class, the parents and faculty desire and deserve, the following requirements must be agreed upon by each senior and his or her parents and will become effective **Monday**, **August 19, 2024**.

- I recognize that participation in the Commencement ceremonies is a privilege and it is not mandatory to receive the diploma of graduation. I fully understand that my failure to abide by the state guidelines could terminate my participation in senior activities and the graduation ceremony.
- I do recognize that like any granted privilege, this privilege may be withheld if the following guidelines including regular daily attendance, are not adhered to.
- I do agree to follow all guidelines set down by the school administration and staff. Failure to follow such guidelines, which will include all suspendable offenses (drugs, alcohol, fighting, defiance, etc.) could be grounds for me not to participate in senior year activities.
- I agree to wear the appropriate cap and gown with no deviations.
- I agree to wear suitable attire during the Senior Luncheon/Breakfast and under my gown at all other ceremonies.
- I agree not to call personal attention to myself, not to behave in any manner that may disrupt the graduation ceremony, or cause embarrassment to the school, class, myself, my family and guests.
- I will not consume any form of alcoholic beverage or illegal substance prior to, or during graduation or at any other school and/or senior class functions (school dances, prom, senior breakfast/picnic, Grad Nite etc.)
- If enrolled in any concurrent classes I agree to complete all course requirements, including having my final grades submitted to the counseling office by <u>Friday, May 30, 2025.</u>
- I agree to (1) pay or clear all debts I owe to Mountain View High School, (2) return all school property for which I am held responsible, and (3) clear all detention by <u>Friday, May 30, 2025</u>. ONLY THEN WILL I BE ISSUED MY CAP & GOWN ON SENIOR CHECK-OUT DAY.
- Should I fail to strictly follow the above the guidelines, I do agree to leave the graduation ceremony and/or practice, if asked to do so by the Mountain View High School Administration.
- I will submit this AGREEMENT of behavior signed by myself and my parent or guardian, <u>regardless of</u> <u>my age before my scheduled registration appointment date</u> or I will immediately begin losing my senior privileges. This AGREEMENT will be effective beginning <u>Monday</u>, <u>August 19, 2024</u>.

Students who violate any of the requirements of the above graduation agreement will have a copy of this document and a letter of no confidence attached to any request for school recommendations or transcripts for a period of five (5) years. Forgery of this agreement constitutes immediate removal of the student from all senior year activities.
