## **One Million Program Agreement**



Program rules and regulations are necessary to protect the students, devices, as well as the school network. The following guidelines are also in place to ensure that this technology serves as an effective instructional tool.

Students and their parents or guardians must agree to the following to become and remain eligible for the One Million Program offering:

- 1. The student will use at least 50% (5GB) of the monthly 10 Gigabyte (GB) data bandwidth requirement. The student must meet the minimum requirement of using 15 GBs or more of total bandwidth over a 3 month period. This usage requirement is not applicable to the Summer months.
- 2. The parent and student agree to follow all El Monte Union regulations and policies governing the use of the MiFi device as well as all applicable State and Federal laws including copyright and intellectual property law pertaining to software and information.
- 3. The parent and student are responsible at all times for the care and appropriate use of the issued MiFi and must adhere to these terms each time the device is used, including when it is not on school property.
- 4. The student will not deface the device or adhere stickers or other markings unless directed to by district staff.
- 5. The parent and student agree to ensure the device is secure and safe. The student agrees to handle the device carefully and protect it from potential sources of damage. When not in use, the Mifi should always remain in the district-provided carrying case or equivalent.
- 6. The parent or student must report theft (or suspected theft), loss, damage, or malfunctioning of the MiFi to school personnel immediately.
- 7. Upon request, the parent and student agree to deliver the issued Mifi to El Monte Union High School District staff for technical inspection, device inventory, or other information.
- 8. The student agrees to abide by the district's Responsible Use Policy, which can be found at <a href="https://www.emuhsd.org/rup">www.emuhsd.org/rup</a>
- 9. The MiFi, case, and charger are the property of the El Monte Union High School District. All such issued equipment shall be returned to the school district in the event that the student withdrawals from the district.
- 10. All activity on the MiFi will be filtered and logged by El Monte Union High School District as well as the One Million Project Foundation. Any attempt to disable the system's internal filter may result in disciplinary actions as well as removal of this free service to the student.

The El Monte Union High School District will cover all repairs due to normal wear and tear or defective parts. Any accidental damage or repairs related to negligence will be subject to the repair & replacement fees as stated on the Access for All website. As with other instructional materials (i.e. textbooks), the family and student will assume the cost of device replacements (up to \$100) due to theft, destruction, or loss. Devices reported as stolen require that parents notify police and provide a copy of an official police report to the school administration.
