1. Sign-in and Welcome

Mrs. Erica Mondragon (SEMHS), DELAC President, called the meeting to order at 5:55 p.m. with eight (8) members present.

- 2. Mrs. Erica Mondragon (SEMHS), DELAC President, asked the members to review the agenda. Due to lack of quorum, there was no motion for revisions or approval. The meeting was held as an informational meeting.
- 3. Mrs. Erica Mondragon (SEMHS), DELAC President, asked the members to review the minutes for February 28, 2019. Due to lack of quorum, the approval of the minutes was tabled until the next DELAC meeting.
