Each Local Educational Agency (LEA) with 51 or more ELs must form a DELAC unless the district designates for this purpose a subcommittee of an existing districtwide advisory committee. Parents or guardians, or both, of pupils of limited English proficiency who are not employed by the district shall constitute a majority of the DELAC. (EC sections 52176[a], 62002.5; 5 CCR Section 11308) [I-EL 2.0] |
| | 2. The DELAC shall advise the school district governing board on all of the following tasks: |
