11/19/2020	1. Each Local Educational Agency (LEA) with 51 or more ELs must form a DELAC unless the district designates for this purpose a subcommittee of an existing districtwide advisory committee. Parents or guardians, or both, of pupils of limited English proficiency who are not employed by the district shall constitute a majority of the DELAC. ( <i>EC</i> sections 52176[a], 62002.5; 5 <i>CCR</i> Section 11308) [I-EL 2.0]
	2. The DELAC <b>shall advise</b> the school district governing board on all of the following tasks:
