4. Compliance Item: Learning Continuity Plan

Mrs. Echeverria reviewed the sections of the Learning Continuity Plan. She addressed questions from the DELAC members regarding tutoring, attendance notifications for distance learning sessions, mental health services especially for Special Education students, and training for parents on technology so they can support their children in distance learning.

The DELAC asked the superintendent to respond to the following questions:

- Notifications to the parents of students who have not logged in their participation during their online classes are taking place throughout the day, and parents are receiving phone calls while they are at work. When they check with their child, their child assures them that they were present but they forgot to indicate their attendance by answering the participation questions. This creates stress and frustration on the part of both parent and child. Couldn't the calls be made in the evening after work hours and after the attendance has been reconciled with the teachers?
- Parents are concerned that they are not equipped to support their child in distance learning. <u>Will the district provide training on the use of technology in the distance learning environment</u> and training to provide parents with the skills they'll need to support their child? <u>Will parents be provided with a Chromebook so that they can participate more effectively in the</u> <u>virtual ELAC and DELAC meetings and/or training sessions?</u>

The superintendent's response will be sent to DELAC member by mail, and a copy will be available on the district's website.
