1. Sign-in and Welcome

Mrs. **Gloria Garcia** called the meeting to order at 5:40 p.m. with eight (8) members present.

2. Mrs. **Gloria Garcia** asked the members to review the agenda.

4. Ms. Alvidrez reviewed the district-wide student survey results and the committee members had the opportunity to comment and ask clarifying questions. The data on the D & F rates for the 2015-16 and 2016-17 school year were also reviewed. Committee members worked in pairs to compare the data between the fall semester and the spring semester of each year and compare one school year to the other. Committee members had the opportunity to share their observations and ask questions. After reviewing the data, the committee members reviewed the list of the 2017-2018 LCAP activities funded under the Supplemental and Concentration grant. The focus was on the activities related to services and support for English learners.

5. Ms. Alvidrez reviewed the proposed revision to the reclassification process that would include the new English language proficiency results from the English Language Proficiency Assessment for California (ELPAC). The committee recommended that the revised Interim English Learner Reclassification Process be presented to the District Board for approval.
