# COC Annual Written Report

## March 2, 2011

It is with great pleasure, we the members of the EMUSHD Citizen Oversight Committee (COC) present to you our annual report of the construction projects funded with Measure D General Obligation Bond funds. Over the past 12 months much work has been completed at Arroyo High School and Rosemead High School. Additional construction on the South Campus at El Monte High School and the District Office has begun.

The COC meets quarterly where the District Administration provides updates on construction and information on future projects. In addition to attending both ground breaking and ribbon cutting ceremonies, the COC members are given the opportunity to tour the construction sites.

Last Spring when school ended both Arroyo High School and Rosemead High School were heavily under construction; when school opened this fall both school sites were beautifully transformed into college-like campuses. Upon visiting both schools on September 18, 2010 we were awe struck with the transformation of Arroyo High School and Rosemead High School. Mrs. Marcella Hernandez and Mr. Victor Becerra, spoke during public comment at the October 6, 2010 Board meeting as to how impressed they were with the facilities and quality of construction. Mrs. Hernandez stated. "I am so pleased that everything that was shown to us on drawings is now a reality and I am so excited that my two children are now benefiting from the construction." Both Arroyo High School and Rosemead High School were awarded to RC Construction and both projects were under budget by a total of \$10 million, thus insuring that the new District Office project was able to begin in fall 2010.

Additionally, we were just informed that both are expected to be completed mid to late April 2011; three months ahead of schedule.

The students of Arroyo High School and Rosemead High School will greatly benefit from the new classrooms, science labs, libraries and other facilities completed. Both of these projects are wonderful additions to the District and Cities of El Monte and Rosemead.

The COC anxiously awaits the sale of the next series of GO Bond so the remaining construction projects at El Monte High School, Mountain View High School, Fernando R.
