B. 1)

Norma Macias, Director of FMOT, provided an update on current bond projects. The following information has been presented to the board of trustees at the board meeting. Norma distributed a facilities update booklet and proceeded to review the Measure D Bond Series A, B, C issuances, transfers from other fund, money allocated, and balance as of 10-12-17 to be \$17,433,353 from the \$148 million.

She presented in detail the expected expenditures to total approximately \$5.2 million. She further discussed the 2017-18 proposed budget. Presentation included events such as ribbon cutting of field house at SEMS on September 18; upcoming projects at MVHS cafeteria; EMHS stadium project; and MVHS gym modernization.

A consulting firm, One Source, has been hired to provide finalization and DSA certification from previous projects. Status on DSA certification include the following: Certified: SEMHS Snack Bar

Mr. Thomas began by advising members that the board had approved the request to consider to modify the number of members of the BCC from eight members to seven members with two alternates.

An attendance log was routed among the members to view history of meeting attendance and members were asked if they would volunteer to become alternates. It was emphasized that this action was not meant to shame anyone, but it was a probable solution to reduce the challenge of meeting quorum and conduct the scheduled quarterly meetings.

Mr. Ken Liu volunteered to be an alternate for the remainder of his term reason son graduated in 2017 and he felt another parent with an attending student would be more beneficial to the committee.

Mr. Macias expressed a desire to continue his membership and explained his being absent from meetings was due to job commitments and further requested that meetings be held in the early part of the week since he travels the later part of the week.

Mr. Thomas stated he would reach out to the absent membership and find out what their status will be.

Mr. Thomas stated that based on his experience, that the ideal schedule to conduct quarterly meetings would be during the months of April, July, October, and January. These months do not conflict with ongoing holiday and school/city events.

Because bylaws specify a mandatory meeting in March to produce the annual report and present it to the board, it may be amended to be either March or April if needed.
