- F. Mr. Elatar introduced Mr. William Perez from Bernards Construction in Norma's absence. Mr. Perez presented a handout with information on current projects. The handout included a budget recap of the \$140 million Measure D bond of 2008. A schedule of expected expenditures was reviewed which included the purchase of district-wide furniture for South El Monte High School's Field House, El Monte High School's Stadium Project, Mountain View High Schools Gym, Arroyo High Schools roofing and district-wide electrical alarm systems. An update report was given on the fire alarm system. The bleacher project is estimated to be completed the first week in June. The Mountain View High School fire was mostly covered by the insurance but other costs were covered by additional funding. All A/C units are being considered for upgrades since most are 15 years or older. The handout also included status of DSA certification projects waiting to be approved. A conversation took place regarding the issuance of the remaining bond money. The assessed values have varied and this final issuance may be available in 10 years. Mr. Elatar stated that funding from other sources have been explored to ensure completion of the projects. He further discussed information regarding the solar panels, not from a bond, which will be started soon. The panels will generate savings in the future years and will pay the loan.
- G. Mr. Elatar introduced Dr. Brian Bristol, the principal at Rosemead High School. Dr. Bristol explained in detail the condition of the football field and the need to explore artificial turf. The "Band-Aid" approach through the years have left the field in dire need to upgrade. Seeding has been considered but the turf would be more beneficial.
